SISA Awards Dinner 2008

Overview

The Self Insurers of South Australia (SISA) represents South Australia's largest private sector employers and the public sector, totalling 36% of the State's workforce by remuneration.

In the second half of each calendar year, SISA holds an annual Awards dinner. In previous years this event has attracted up to 240 people and has been acknowledged as a high point on the SISA calendar. So popular was the 2007 event that at the time of writing, SISA has an indicative attendance listing of 436 people for the 2008 event.

The Awards Dinner therefore presents a great opportunity for sponsors to network with self insurers and market their services.

The 2008 Awards Dinner is planned for 15 August 2008 at the Adelaide Entertainment Centre. SISA is seeking sponsors for this event.

Unlike the 2007 event, the 2008 Awards Dinner will be held in the main arena of the Entertainment Centre, with pre-dinner drinks in the foyer. 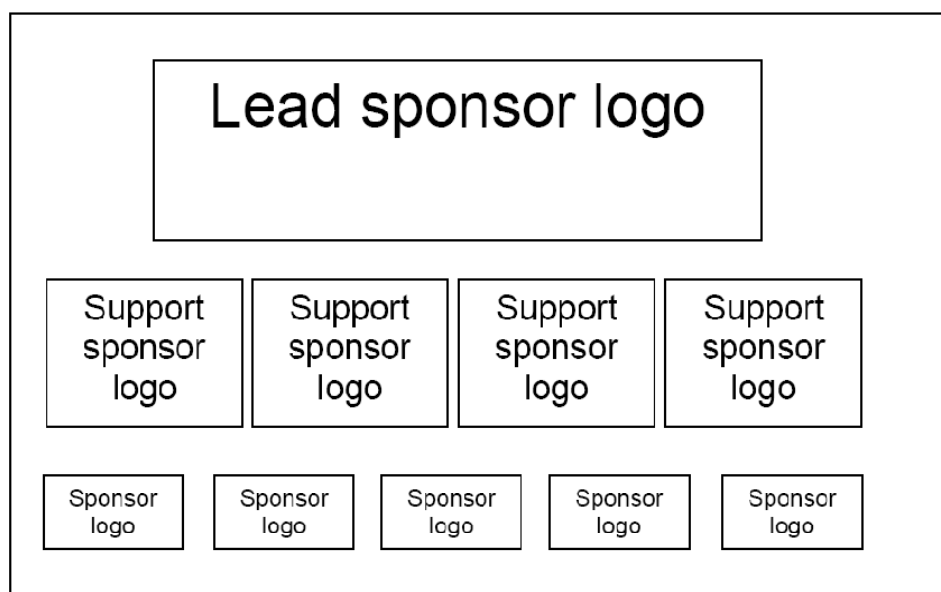
Lead sponsor*
