## ANNUAL GENERAL MEETING - $\mathbf{2 5}^{\text {th }}$ AUGUST 2004

## Chairman's Report

For the second year in succession, SISA's activities were dominated by a review commissioned by the Government. Following the Stanley review of Workers Compensation and Occupational Health Safety and Welfare systems in 2002/2003, Professor Dennis Else and Mr Alan Clayton were commissioned to conduct a review of Self Insurer Standards and Criteria in 2004.

The WorkCover Corporation announced the appointment of Professor Julia Davison, formerly head of Flinders Medical Centre as its Chief Executive Officer, and there followed a major review of the Corporation, in which the senior management team was restructured and all positions advertised.

SISA contracted with Natalie Bottroff and Associates to stage a series of successful Occupational Health and Safety and Injury Management seminars.

Once again membership continued to grow, with 4 new full members and several organisations joining SISA as associate members.

## MAJOR ACHIEVEMENTS

The Else / Clayton review of Self Insurer Standards and Criteria is the most important project for self insurers since the inception of WorkCover. Previous initiatives which lead to the restructuring of the performance standards were significant, however for the first time a review of all aspects of self insurance was sought.

SISA's submissions to the Else / Clayton review have been based on the assertion that self insurance in South Australia should be encouraged for the economic benefit of the state. Following a lengthy process of consultation, SISA prepared a most comprehensive submission and response to an issues paper developed by the consultants.

Whilst the review process is ongoing, with recommendations only recently being released, it is important to note that many of the issues identified by SISA have been included.

During the year Mr Steve Standen, SISA Chairman, and Mr Darryl Turner, Manager made appearances at Parliamentary Legislative Committees on Occupational Health Safety and Welfare and Workers Compensation, to promote the benefits of self insurance.

SISA subscribed to the Business SA Making a Difference Program on the basis that it would produce a series of relevant OHS\&W seminars focused on organisational and cultural issues

SISA's association with Natalie Bottroff and Associates, was most productive, with three seminars conducted during the year. The seminars, including a contribution from SISA to Safe Work week, were well attended and were most successful, not only financially, but it is also clear that SISA "lifted the bar" with the relevance and quality of it's events. As a result, a further engagement with Natalie Bottroff and Associates for the coming year has been made.

SISA's contribution to the national scene continued with the reappointment of Darryl Turner as Chair of the National Council of Self Insurers. Most states have made funding contributions to the National Council to establish a base upon which future initiatives can be planned. Mr Turner has lifted SISA's profile through addresses at interstate conferences, including the chairing of a national self insurance summit held in Sydney in May.

The establishment of regular meetings with Ms Barbara Rajkowska, Chair of the WorkCover Workers Compensation Committee, and employer representative on the WorkCover Board, has enabled SISA to identify issues of concern for discussion at the Board level. Ms Rajkowska also attended a meeting of the SISA Executive.

WorkCover CEO Ms Julia Davison presented to a large audience at a general meeting of members in July. Ms Davison demonstrated a commitment to establish a close liaison with self insurers by attending a meeting of the SISA Executive and by visiting self insurers Zinifex at Port Pirie, and One Steel at Whyalla.

An inaugural meeting of a South East injury management networking group planned for August was deferred due to unforeseen circumstances

## STATUS OF MAJOR CURRENT ACTIVITIES

The consultation process following the public release of the recommendations from the Else / Clayton review is the current major focus for SISA and its members.

SISA will enlist the support of its full and associate members to participate on working parties to address the various recommendations and make submissions to WorkCover. It is likely that the consultation process will continue into 2005.

Positive discussions with WorkCover and Deloitte to agree a transparent, activity based costing model for calculation of the self insurer levy rate have taken place. The proposal was included in the considerations of the review and SISA will need to pursue adoption of the activity based costing model for the benefit of its members.

Despite ongoing consultation the issues relating to recoveries from negligent third parties involving host employers and labour hire remain unresolved and as with the levy rate it is important to pursue an outcome for members in this most complex area.

SISA is participating on a working party convened by WorkCover to address issues relating to Section 58 B/C application to self insurers.

Ongoing issues relating to self insurer evaluations against the performance standards will be addressed in considering recommendations from the Review.

In a bid to establish a more focused employer stakeholder information and lobby group the Business SA OHS\&W consultation meetings have been restructured to include an injury management focus and to address current issues. This will assist SISA to more closely liaise with Business SA in matters of common interest.

With Natalie Bottroff \& Associates planning is underway to conduct a seminar in Occupational Health Safety and Welfare in October 2004 in conjunction with the Safety Institute of Australia.

Despite the recommendations of the Productivity Commission enquiry into OHS\&W and workers compensation, the federal Government has indicated that it will not at this stage support opening up of the ComCare Scheme as a means of allowing a National Scheme. Nevertheless discussions to consider consistent National auditing standards are taking place and SISA will be involved in that process.

SISA is continuing to develop its website and encourages members to visit it regularly as a source of current news and information.

## FUTURE ACTIVITIES

The newly elected Executive Committee will review and publish a corporate plan for SISA in 2004/2005. It is likely that the focus will be in the following key areas:

- Ongoing involvement in consultation processes in respect of the recommendations from the Else/Clayton review.
- Establishment of a lobby group and focus to maintain self insurance as an important factor in business growth and development in the state.
- Establishment of improved information systems for benchmarking and reporting.
- Continued development of profile and initiatives in the national arena.
- Establishment of alternative income streams through the provision of injury management and associated training programs and enhancement of the promotional section of the SISA Website.
- The provision of three (3) high quality seminars including a Trade Expo and workshops in May 2005.
- Maintenance of a responsive service to both Full and Associate members including additional benefits for Associate Members.
- Maintenance and development of resource and asset basis.


## MEMBERSHIP

During the year SISA dealt with a number of issues from its member organisations. Most contentious of these continue to involve the evaluation process and as reported earlier this will be dealt with as part of the Else Clayton review consultation.

It is noted that Levi Strauss Limited and Michell Australia surrendered their self insurer licences during the year due to organisational restructures which left them unable to comply with the requirements of the code of conduct for self insurers.

## STAFFING/RESOURCES

After a short period of employment SISA lost the services of its Administrative Assistant Ms Teresa Muscara, who resigned for personal reasons. In Teresa's place SISA has been fortunate to have gained the services of Ms Melissa von Laue. Melissa commenced employment with SISA as a Personal Assistant/Office Manager on 1 March 2004 and has already indicated that she will be a most valuable acquisition to the organisation.

An OHS\&W Risk Survey of the SISA premises was conducted and minor matters identified are currently being addressed.

Minor maintenance to the premises was carried out during the year and given the financial result to be reported at today's meeting the incoming Executive Committee will be able to consider some more extensive upgrading in the coming year.

This has again been a most satisfactory year as SISA has met the consultation demands of an important review and generated additional income through growth and resource management. The auditors report to be tabled at today's meeting indicates a most favourable outcome.

## Other Initiatives

As has been previously recorded, a great deal of the sub committees work was involved in addressing the consultation process for the Else Clayton Review.

A sub committee representative group consisting of Ms Elinor Bolt, Ms Lyn Hodge and Ms Jan Scott provided input into a WorkCover early intervention model for rehabilitation.

A code of conduct for in house rehabilitation providers is in the process of being developed and will be incorporated into an Injury Management Training Program.
